#### **Project Update**


- On June 10<sup>th</sup>, the New Terminal One (NTO) reached financial close on the terminal for the first phase of the project and executed a lease with the Port Authority allowing construction to proceed
- The Port Authority Board approved the addition of Ferrovial as a lead financial sponsor alongside Carlyle, JLC Infrastructure and Ullico
- The 2.4 million square foot terminal aspires to be among the top- rated airport terminals in the world
- NTO will create more than 10,000 jobs and strengthen the economic ties to the community
- Groundbreaking is slated for this summer, with the first new gates opening in 2026




NTO recognizes the importance of creating jobs, supporting local businesses, promoting diversity, and delivering opportunities to the local community

#### **Reaffirming Our Commitments**

- 30% M/WBE goal (20% MBE, 10% WBE) across all phases and disciplines of the project
- 3% SDVOB goal across all phases and disciplines of the project
- Hiring goals for minorities and women (40% for laborers, 30% for other trades and 7% for women)
- Prioritization of local firms starting with SE Queens and Western Nassau, followed by Borough of Queens and New York /New Jersey Port District



#### The New Terminal One Redevelopment Project

To be built on site of the existing Terminal 1, Terminal 2 and former Terminal 3

2.4M square feet of terminal space, 250% larger than existing terminal

More than **300,000 square feet** of dining, retail, lounges, and recreational space, offering passengers a uniquely New York sense of place.

### Carrol Bennett, Acting Chief DEI Officer, PANYNJ



- Appointed to CDEIO at the Port Authority of New York & New Jersey in 2021 with over 30 years of executive management experience to her role.
  - Previously serving as the Chief of Staff for the Office of Diversity, Equity & Inclusion, providing advice, guidance, support, and management for a wide range of related programmatic initiatives aimed at furthering the Agency's DEI agenda.
- Prior to joining ODEI, she held many key leadership positions at the Port Authority, including, Assistant Director in the Office of Capital Planning & Asset Management where she assisted the Chief of Capital Planning, with the management of the Port Authority's \$32 billion ten-year Capital Plan.



### PA Commitment to Increase MWBE Utilization

- In 2018, Board approved new MWBE participation goals of 30% (20% MBEs and 10% WBEs) across all procurement categories
  - Prior to 2018, MWBE goals were focused on Construction
  - After the Board's 2018 resolution, expanded focus to additional categories:
    - Architectural & Engineering (A&E) Professional Services
    - Goods & Services
    - Non-A&E Professional Services
    - Technology Services

#### > Various strategies implemented to increase MWBE utilization

- Educate internal and external partners regarding Diversity within Diversity, and enforcing 30% goal on every phase of a project (ex: design-build)
- Host series of forums and training sessions on Doing Business with the Port Authority
- Eliminated barriers:
  - Unbundle large contracts into smaller contracts to increase opportunities
  - Aligning firm requirements to better match scope of work
  - Reducing onerous financial requirements (ie: bond waivers, insurance requirements)
  - Training RFP selection committee members on unconscious bias



#### JFK Redevelopment

- \$18 billion to transform JFK into a unified, world-class international gateway (Terminal 1, Terminal 8, Terminal 4, and Terminal 6)
  - New JFK New Terminal One deal signed on June 10<sup>th</sup>
- Senior Port Authority Leadership: Engaged with private partners to assure commitment to achieve MWBE goals with regular follow-up
- Community Engagement: Multiple targeted programs in partnership with the local community
  - 4 focuses to the Community Development Program: Business Development, Career/Workforce Development, Education, and Environmental Stewardship
- Project Readiness for JFK: Matching events to introduce chosen primes to potential local subcontractors
- Goal is to achieve similar positive results that were achieved on LGA Redevelopment Program and are now being achieved on EWR Redevelopment Program


